



## Riverside team members set a new record – more than \$161,000 raised in 30 days

Riverside team members are always looking for ways to raise the standard of care. In April of 2019 they did it again through our annual Team Member Giving Campaign.

More than \$161,000 was contributed by 2,718 team members in 30 days to initiatives across Riverside - the most ever raised during a Team Member Campaign. Notably, 69 team members joined the 1915 Club by generously donating \$1,000 or more.

Champions from all over the health system focused on campaign awareness with their colleagues. They endorsed letters to their peers, led fundraisers and even went on camera to talk about what giving to Riverside means to them.

Each year the five geographic regions compete against one another for a participation percentage award. This year for the first time, the Williamsburg region took home the trophy under the leadership of Adria Vanhoozier and Carrie Karnes.

## Riverside Leaders Support Memory Care Initiatives

Every day Riverside team members encounter patients and families struggling with memory-related diagnoses and conditions. During October's Leadership Conference in Williamsburg, colleagues contributed more than \$24,000 to support memory care initiatives to benefit patients and their families.



## Riverside Day of Giving Fully Funds Four Projects

Riverside's Day of Giving in December was celebrated with a twenty-four hour fundraising campaign to fund patient experience projects submitted by Riverside team members across the health system. In an overwhelming response, all four projects were fully funded within 24 hours.

The Women and Infant Care services at Riverside Regional Medical Center and Riverside Shore Memorial Hospital raised \$9,220 to purchase Newborn Anne Manikins for their units. These manikins provide **lifesaving infant care** by allowing practitioners to keep their skills sharp at all times, especially on skills that are not frequently used, by enhancing patient safety and by ensuring we continue to provide the highest standard for the smallest patients in Riverside's care.

The Riverside Behavioral Health Center (RBHC) raised \$5,466 to purchase **sensory, recreation, and art therapy supplies** for all residents with a focus on adolescents. Sensory stimulating items can help create a calm and therapeutic environment during treatment at RBHC.

Peninsula Cancer Institute in Williamsburg raised \$6,318 for a **monthly speaker series** to connect patients, survivors, and caregivers. These sessions will provide expert tools for coping, interactive activities, and integrative therapies all aimed at addressing

the physical and emotional challenges of cancer. This series is part of Riverside's integrative approach to Cancer Care, inspired by the work of the late Dr. Mark Ellis whose memory lives on through the Dr. Mark E. Ellis Endowment Fund.

Riverside knows that after discharge some patients enter environments that are not conducive to healing. This project provides at-risk patients with **post-hospital care kits** to improve their opportunity to heal after they leave the hospital. Specifically, the \$5,900 raised addresses three of the most frequent diagnoses: congestive heart failure, diabetic complications, and orthopedic injuries. These kits include personal hygiene products, cardiac scales, cast/wound covers, and heel cushions, tailored to the patient's individual needs.

Riverside is grateful to all who supported these projects, and especially thankful for Riverside Foundation Board Chair, Conway Sheild, and Riverside Foundation Board Member, Steve Spain, for providing matching funds.



Gifts to the Riverside Behavioral Health Center allow us to continue to grow programs offered to our adult and adolescent resident populations.

## Huntington Ingalls Industries Education & Training Center Established at the Celebration and Dedication of the Dr. Brandon D. Rogers Simulation Lab

On Oct. 29, the eve of what would have been Dr. Brandon Rogers's 32nd birthday, Riverside Health System leadership and team members, supporters, and special guests officially kicked off construction and dedicated the future Huntington Ingalls Industries Education & Training Center which will house the Dr. Brandon D. Rogers Simulation Lab and the Riverside Regional Medical Staff Resident and Clinical Education Wing at Riverside Regional Medical Center.



Brandon's family and friends attended the event to honor his legacy after he was tragically killed in a car accident in June 2017. "For somebody who was with us just a short period of time, he made such a big impact," said William B. Downey,

CEO of Riverside Health System. As of Dec 31, 2019, more than \$1.2 million has been raised from over 400 donors in support of the simulation lab and related training facilities, and in Brandon's memory.

"When we first came up with the idea, it was conceived to be a very small lab with a few simulation models," said Mike Doucette, Hospital President at Riverside Regional Medical Center. "The concept has since grown into what will be a truly world-class training center."

Several key contributions have been made to benefit this state-of-the-art-facility. Lead partners, Huntington Ingalls Industries and Newport News Shipbuilding, who use simulation modeling in their everyday business, recognize the importance of investing in education, training and technology which has been shown to improve patient safety and improve healthcare competency.

The Center will house the Dr. Brandon D. Rogers Simulation Lab and the Riverside Regional Medical Staff Resident and Clinical Education Wing. Simulation instrumentation and virtual reality tools housed in the center will enable clinicians to maintain and frequently update skills without risk to patients. In a controlled setting, physicians and staff will be able to enhance their dexterity with high-risk procedures they seldom see, and more quickly acquire new skills as techniques and equipment continually evolve. Additionally, the Clinical Education Wing will include resident studies, libraries, a lounge and classroom space.

Once complete, the state-of-the-art training facility will benefit more than 80 surgical specialists, more than 55 emergency medicine providers, medical residents in multiple specialties, and numerous other nursing and clinical staff each year. Construction of the Center is expected to finish in the late spring of 2020.

### Anne Talbot Evans Memorial Scholarship

The Anne Talbot Evans Scholarship was established in 2013 to honor her lifelong work and dedication to surgical services. Anne is remembered for her quick wit, thoughtful wisdom, and compassion. This annual award is presented to students enrolled in the Riverside College of Health Careers Surgical Technology program or Registered Nursing program with plans to pursue a specialty in surgical nursing. Surgical technologists must demonstrate a wide-reaching technical understanding of many different types of procedures. Surgical nurses have to be highly skilled and multi-taskers and can choose to concentrate in one area such as obstetrics or cardiac surgery. Both surgical techs and nurses perform essential hands-on roles with a goal of functioning seamlessly with others, often serving as the backbone of the operating room team. ### Florence Gomez Fiscella Memorial Scholarship

Florence Gomez Fiscella demonstrated a steadfast commitment to education and community organizations along with her devotion to her family and her patients. After graduating from the Cochran School of Nursing at St. John's Riverside Hospital in New York,

Florence served as a Registered Nurse through the Army Nurse Corps. She relocated to the Peninsula in 1949 and continued to care for those in need at both the Veterans Administration and Riverside Hospital. This memorial award, established in 2019 to honor her legacy, will provide valued assistance to those who wish to become a Licensed Practical Nurse through the educational nursing programs at Riverside's College of Health Careers. Congratulations to the inaugural Florence Gomez Fiscella scholar, Catherine Culpepper.

### Petro & Sanderson Educational Support Fund

This annual scholarship award was established in 2019 in honor of Faye Petro Gargiulo's many years of leadership and service to Riverside Health System and to celebrate her passion for education and health care. Of her many roles, Faye most recently served as a Vice President, overseeing the Riverside Foundation as well as physician recruitment and facilitation of clinical and health services research. Supported by Faye and Dr. J. Frank Sanderson, Jr., this award assists future providers at Riverside's College of Health Careers who are committed to providing exceptional care and who display a personal connection to the mission of Riverside – to care for others as we would care for those we love. ## How Scholarships are Created and Sustained at Riverside



### Endowed Scholarship

A cumulative gift of \$50,000, paid in increments up to five (5) years, will establish an endowment fund that will produce up to \$2,500 every year in perpetuity.

### Named Scholarship

A contribution of \$25,000, paid in increments up to five (5) years, will establish a named scholarship fund and provide up to \$1,000 in support annually as funds are available.

### Annual Scholarship

A contribution of \$1,000 or more will create a designated scholarship in a category determined by the donor and awarded in the same year.

### General Scholarships

You can give aspiring health care providers an opportunity to act on their passion and expand their knowledge by contributing any amount. Riverside will use your contribution to create additional scholarships or increase an existing award.

## Patriots Colony Resident Philanthropy Committee Helps Team Members Achieve Their Goals

In 2018, Patriots Colony retirement community established a Philanthropy Committee to help guide the distribution of philanthropic funds raised through the Riverside Foundation allocated to Patriots Colony. The resident committee members feel a strong desire to give back to the community they love and that has cared for them and their spouses. Committee members and Patriots Colony leadership work together on projects that are inspired by residents.

Their biggest project to date, the Team Member Scholarship, began when resident Jim Edwards envisioned creating a scholarship fund for Patriots Colony team members to help them pursue health care education and further their careers at Patriots Colony. Jim is passionate about helping others achieve their life goals. He worked with the Riverside Foundation to establish the endowment portion of the fund with an initial gift and multi-year pledges to honor his mother who was a registered nurse.

While the endowment grows to a level of sustainability, an annual fund was created by Committee members Mac Armstrong and Bob Evans so that scholarships could be awarded immediately. “While the endowment fund will be here for a long time, we don’t want to wait until it builds up to see how this scholarship fund will help team members, we want to help them now – and the early recipients love it.” states Mr. Armstrong.

In addition to the Philanthropy Committee, several residents provided significant support to make this scholarship possible. Because of this generosity, two team members each received two scholarships this year. Chris McHose is pursuing a bachelors and masters in health care administration, and Jessica Garrenton is pursuing a nursing degree.

## Riverside Behavioral Health Center Inspires Spain Family

As most of us are pouring our morning cup of coffee, Steve Spain has long been hard at work for several hours. As the founder and president of Spain Commercial, Inc., Steve relishes early morning productivity that will set the tone for his work day. In fact, he feels that his most important morning assignment is sending inspirational daily texts to each of his employees as well as to some of his sub-contractors. Steve is a motivator and a dreamer. He thrives on bringing out the best in people. “Everyone has greatness inside of them,” he says. “Sometimes they just need help bringing it out.”

Steve and his family developed and maintained a strong faith and desire to give back to their community. Through Spain Commercial's work renovating Riverside Behavioral Health Center (RBHC) he learned first-hand about the services at RBHC which include acute care, crisis assessment and residential treatment programs for both adolescents and adults. The adolescent residential unit provides care for teens ages 12-17, who undergo long-term, intensive treatment focused on psychological and/or emotional difficulties as well as learning to cope and process life experiences of extreme distress. Steve also realized the unique challenges and complex problems children and teens in this facility face. In fact, youth are often referred to Riverside's adolescent program from across the state, where efforts to provide stabilizing treatment had been previously unsuccessful. Steve began dreaming about how he could help to create a better future for these

kids. "We are all here on this earth to help others," he states. With a particular fondness for young people, Steve recognizes that the world is, in many ways, harder for our youth today, and he looks for ways to inspire and mentor them.

The average length of stay for children at RBHC is 188 days. Clinicians and Therapists help patients to develop effective coping skills and

deliver individualized therapy and care aimed to strengthen interpersonal and family relationships. The unit is designed to provide a safe, structured and home-like environment. After hearing this, Steve and Grace Spain, along with their family (and the extended family at Spain Commercial) made their first gift to the facility, providing art supplies, new and upgraded televisions, and game stations for the boys and girls recreation rooms.

In the years since their first gift, Steve and his family have remained

committed to improving the residential experience and quality of life for this group of young patients. The family's continued generosity, along with additional community support, will expand recreational therapy programs, enhance the RBHC's outdoor courtyards, and enrich the resources and technology available for use in the classrooms and for therapy activities.

"There is no better feeling than doing for others – to see them grow as men and women," says Steve.

"I think there is a desperate need to educate as to how lifestyle connects to cancer development," she says. A former nurse and tireless volunteer, Patti is doing her part to bring about change by generously investing in the Riverside Foundation to support cancer education and prevention programs in memory of Lew's life and in honor of his legacy as former president and chief executive officer of Riverside Health System.

Since 2019, Patti has hosted a series of focus groups, gathering oncologists, caregivers, and community leaders to discuss the barriers to cancer education. Patti's goal is to coalesce friends, patients, and local community members to invest in Riverside. Donations can assist Riverside in several crucial ways, including the enhancement of access to nurse navigators who assist patients every step of the way throughout their cancer journey, resources to expand genetic counseling to help pinpoint at-risk individuals and act early to prevent cancer, and more access to life-saving clinical trials close to home.






### Debbie Atkinson







### Frances Ellis






### Diana LoVecchio

### Newport News Shipbuilding





### Rick and Cathy Pearce





### Jesse Doswell Dutton



Jesse Doswell Dutton was a prominent Gloucester businessman and supporter of the construction of Riverside Walter Reed Hospital on the Middle Peninsula in the late 1970's. After he retired from his hardware store in Gloucester,

he served many years as a volunteer at the hospital. Mr. Dutton left a generous bequest to the hospital, establishing the J. Doswell Dutton Family Care Center – a home-like setting for families to relax in while visiting their loved ones at the hospital.

### Ruby Pope Drumm



In 1948, Ruby Pope Drumm graduated from the Riverside School of Professional Nursing and then spent more than 20 years in the Air Force as an RN. When she passed away in 2004, she left the single largest individual gift ever to the Riverside Foundation. ## BayPort Credit Union Names Outdoor Ambulation Path at Riverside Rehabilitation Hospital in Honor of Former CEO George Dudley, Jr.

Jim Mears, BayPort Credit Union's current President and CEO, will always remember the phone call he received on March 23, 2018 from Donna Dudley. She called to share the upsetting news that her husband and BayPort's CEO at the time, George Dudley, Jr., had suffered a stroke. In the weeks that followed, Jim visited George as he recovered at the former Riverside Rehabilitation Institute in Newport News. "While George's ability to walk and communicate had been impaired, his determination, grit and sense of humor were still on full display," Jim said.

As part of his stroke rehabilitation, George received specialized therapy aimed at restoring his physical, cognitive and behavioral function. "All of us who visited heard George talk about 'the girl who is helping me walk,' or 'the girl who teaches me to talk,'" Jim recalls. "We celebrated when he was able to walk down the hall, then down the stairs and then around the building ... when he was able to say his daughter's name and talk to us about what was going on at work. We were watching miracles happen."

George, who served BayPort Credit Union for 42 years before retiring in 2019, was able to resume his valued consulting role at the office just six months after his stroke. "Without the care of the staff at Riverside, that might not have happened," Jim said.

To show their appreciation, BayPort Credit Union made a generous gift to Riverside, sponsoring an outdoor ambulation track at the new Riverside Rehabilitation Hospital in Yorktown. The BayPort Credit Union Ambulation Path, bearing George Dudley's name, was dedicated on October 22, 2019, not long after the facility's August opening.

"This truly is a tremendous gift for our rehab hospital and our community," said Ed Heckler, vice president of Riverside Lifelong Health and Aging Related Services. "The outdoor ambulation track provides patients and families with an opportunity to challenge themselves by practicing how to ambulate safely over varying surfaces and terrains that we encounter every day. It will directly benefit thousands of future rehabilitation patients, supporting them on their road to recovery."

Jim and the folks at BayPort feel fortunate to support the only freestanding rehabilitation hospital in Hampton Roads and its clinical team as they help patients recover from brain or spinal cord injury, stroke, neurological disease, amputation and orthopedic conditions. "This was an opportunity to not only contribute to Riverside's growth and the amazing work being done, but also to honor the man who means so much to all of us," Jim said. "We hope this project will inspire others faced with similar challenges."

In 2019, one of those volunteers, Colonial Beach resident Willis Slaughter and his wife Pam made a donation to the Riverside Foundation in Barbara's honor shortly before she passed away.

A lifelong member of the local community, Barbara grew up in Essex County before marrying Billy Omohundro and settling in Richmond County, where they raised three children. She worked as an administrative assistant for 35 years and served as Cobham Park Baptist Church's organist for an impressive 60 years.

Before cancer took Barbara's life on October 20, 2019, she spent six years serving in Riverside Tappahannock Hospital's gift shop. "She took her volunteer job seriously and got along famously with all of us," Willis says. "Even in her illness, she loved this group so much." The last volunteer meeting that Barbara attended was to honor a deceased volunteer with a brass leaf on the hospital lobby's Tree of Giving. Recently, the team donated a leaf in Barbara's honor.

Volunteer Coordinator Ellen Copeland describes Barbara as selfless. "She was somebody you'd want to sit down and talk to — easy to be with," Ellen says. "So it only fits that she would feel compelled to give back, to be with people and spread joy, because that's really what she was all about."

It was during Barbara's second battle with liver cancer that the Slaughters, who have both volunteered with Riverside, decided to recognize their friend and fellow volunteer with a gift to the Riverside Foundation. "It's rare that people give of themselves in totality and don't expect anything in return, like Barbara," Willis says. "When someone affects your life and shows how they feel about sharing with others, it becomes an inspiration and, in this case, something to carry forward."

Willis was originally inspired to volunteer when his own family received immense support from hospital volunteers throughout his mother's and sister's illnesses. Paying it forward, he has supported countless other families in Riverside Tappahannock Hospital's surgical waiting area for the past 10 years.

He's thankful that, during that time, he received the gift of knowing Barbara Omohundro. "What a fine lady," Willis says. "What a personality. Name the area — she served in her church, her community, her family and here at the hospital. If you met Barbara you would be glad that, along life's way, she crossed your path."

### ER Donation in Gratitude for Late Husband's Care

Around the time that Riverside Health System acquired Riverside Tappahannock Hospital in 1989, Frances Ellis, Essex County's treasurer at the time, became one of the first women to serve on the hospital's board. She has continued to serve for the last three decades, including a stint as board chair. "I've enjoyed my service to this community," Frances says. "It's just such a good group." An Essex County native, Frances is well rooted in the community where she's been a leader and outspoken advocate for philanthropic support of the hospital. "I don't know a better steward of our organization than Frances Ellis," says Liz Martin, hospital president. "I've learned so much from her. We are so grateful for Frances' leadership, perspectives and intellect." In addition to leading a major fundraising drive that enabled a hospital-wide conversion to private patient rooms, Frances also oversaw an expansion of imaging services and the addition of telemedicine technology.

Though Frances has long known the value of her local hospital, she experienced it firsthand when her husband, Benjamin Ellis, Sr., received care for a series of heart problems beginning in 2018. "Everybody was so careful and reassuring with Ben," Frances says. "It

couldn't have been better for him. And they helped me through all of it." Ben had to visit the Emergency Room twice, the second time with a major heart attack causing a great deal of apprehension for him. "The staff comforted him, and by the time I got there he was settled down," Frances remembers. Unfortunately, despite all possible measures taken and Ben's determination to get better, heart failure later led to his death on June 30, 2019. He was 76.

Especially grateful for the Tappahannock ER team, who also cared for Frances' mother as she suffered from Alzheimer's disease, Frances made a generous donation to honor their service. "This hospital saves lives every day. The ER is just so good. People come from a radius of 50 to 70 miles away, all throughout the Northern Neck. Before we had an urgent care to alleviate some of the ER traffic, they saw everything from cuts and bruises to major things. This staff has to know everything. They are always professional, compassionate and very attentive. Through

the years, they have really stepped up and helped the community tremendously." Frances's intention is that her gift will enhance the ER team's modest break room. "I want the doctors and nurses to have a little comfort area to help them, just to thank everybody for their long, long shifts," she says. "I wanted to do something to make their life a little bit easier and more comfortable."

Frances plans to continue serving on the hospital board for as long as she can, supporting a cause and a team that she believes in wholeheartedly. "The entire hospital staff, from the administration right on through housekeeping and food service, is committed to the hospital and they have been for years," Frances says. "It's the same people that stay on, and they do a fabulous job. They take pride in what they do; they want to help the community and the people. It's a tremendous little hospital that has done remarkable things. It's exciting to be part of it."

## Oncology Nursing Residency Program at RWRH Fills Local Need

Riverside nurses who support and serve Virginia's Middle Peninsula community can now access specialized oncology training thanks to the recently established George T. Abernathy Oncology Nursing Residency Program.

A generous gift to the Riverside Foundation from Susan and Robert McCreary, in memory of Susan McCreary's father, George T. Abernathy, funded the program, the first of its kind within Riverside. Abernathy, an executive for Newport News Shipbuilding, was a well-respected community leader until his passing in 1984. He was a member of the original Riverside Hospital Board of Managers from 1951 to 1984 including a term as Chairman, and also served as a Board Member for Riverside Walter Reed Hospital (RWRH) when it opened its doors to the Middle Peninsula community in 1977.

The McCrearys described a time when Robert was a patient at RWRH and how impressed they were with the nursing team. "We wanted to do something to help the nursing staff" said Robert. "The core thing we are after with this program is to provide advanced education to keep local nurses at our local hospital."

Lasting six to nine months, the curriculum of the oncology nursing residency program will provide learning opportunities such as pre-arranged mentorships, clinical rotations, conferences, educational materials and dinner lectures with nationally known

oncology leaders. Ultimately, the program aims to develop a subspecialty of cancer care nursing and a network of cancer nursing professionals on the Middle Peninsula, and to help prepare nurses to become eligible for the National Oncology Nursing certification. To be considered for the oncology nurse residency program, applicants must demonstrate licensure as a registered nurse, a desire to gain an increased oncology nursing expertise, and a commitment to providing the best standard of care for patients at RWRH and the Middle Peninsula community.

"All of the nurses I've worked with over the years are full of joy and life and a deep desire to serve patients," said Esther Desimini, RWRH president, who will help select applicants with the hospital's Chief Nursing Officer. "This is a fine example of us tailoring our offerings to the community's needs and supporting our nurses who already give so much of themselves and would like to strengthen their sub-specialty expertise."

More than 85% of cancer care in the U.S. is provided in a community hospital, like RWRH, and not in a specialty cancer care hospital. "This generous gift will support ongoing excellence in local oncology nursing care throughout the continuum from RWRH to provider offices, clinics, home health and hospice, and it will ensure we are delivering high quality, evidence-based care to our community," said Esther.

Funds raised will help expand screening and diagnostic services. Last year, more than 5,500 women on the Middle Peninsula entrusted Riverside to perform their annual mammograms. 3D mammography is planned, which will significantly increase the rate of breast cancer detection and the accuracy of future diagnoses. Riverside also plans to provide Transesophageal Echocardiography testing, eliminating the need for more than 100 patients to travel outside of the Middle Peninsula region each year. This new technology uses high frequency sound waves to give a clearer picture of the heart and arteries, elevating the ability to intervene and provide care during cardiac events.
